| Content | The course seeks to convey the most important orientations of psychology and show its different fields of application. Therefore the course will deploy an overview of the psychological discipline, but also provide a more in depth study of some issues, particularly approaches of language and communication, as well as the field of clinical psychology, in particular the fundamental axes of psychopathology, of the personality structure and some elements relating to psychotherapies. In addition, the course will deal with issues directly related to the field of law, such as the psychological expert assessment, but also discussions about what is normal and pathological and those relating to the effects of social change on subjectivity. | | | | |
