Evaluation methods	During the exam session in January each student submits an individual assignment. Exams during the August/ September session are the same. These assignments demonstrate their command of the theoretical foundations and practical aspects of subtitling, supertitling and audio description.
Teaching methods	Instruction takes place in the computer room on machines running EZTitles© software. Attendance is compulsory.
Content	Students are trained in the use of the professional program EZTitles©. A variety of audiovisual files are used: short films, animated cartoons, documentaries, and so forth. The teaching is professional training. Students are trained to deliver a final product that would meet the quality requirements of the workplace
