Evaluation methods	<p>During the term: formative assessment.</p> <p>January and August/September sessions: written examination.</p> <p>Students are required to take one written examination per translation workshop (i.e. economic, legal, and scientific/technical translation) in connection with the topics dealt with during the term.</p> <p>The final grade will consist of the results of the written examinations (50%) and the oral presentations (50%).</p>

Content	<p>These Workshops aim at introducing the students to specialised translation from Spanish into French of texts relating to the fields of law, economics, technology and/or science.</p> <p>The Workshops are designed to familiarize the students with key concepts in each field as well as to the relevant terminology, phraseology and style. They consist in repeated translation exercises under the guidance of the teacher. Some translation exercises will involve computer-assisted translation tools or machine translation.</p>
