Evaluation

The evaluation methods comply with the regulations concerning studies and exams. More detailed explanation of the modalities specific to each learning unit are available on their description sheets under the heading "Learning outcomes evaluation method".

Semestrial clinical evaluations: these evaluations are established (in writing) by the practical training course supervisor of each candidate and aim to assess different items. The evaluations of all the candidates are reviewed during the two semestrial meetings of the ensemble of the practical training supervisors.

At the end of theses three years of training, each candidate will be evaluated during the course of an interview aimed at testing his general knowledge acquired in Internal Medecine. Further to the application of the Royal Decree of 16 March, 1999, at the end of the first two years of training, the candidate will receive an attestation proving that he has successfully accomplished a specific university training course.
